VISUAL FRINGE EXHIBITION at off-site locations in downtown Windsor

Terms:

A) Artist is responsible for installation (set-up), de-installation, framing, matting, packaging and any such preparations of the artwork for exhibition and transportation. Artist is responsible for pick-up and delivery of artwork. Artist agrees that artworks and any special items needed for proper installation of said works (including equipment, hardware, electrical cords, lighting, etc.) will be supplied by the artist and will be available at the exhibition site when required for installation.

B) Artcite Inc. will act as agent for the artist only for the duration of the exhibit and only for those works displayed in the exhibition. There is a 15% commission charged on exhibition sales.

C) Artcite Inc. will provide all-risks insurance for artworks while on display or while on exhibition site only; Artcite Inc. is not responsible for loss or damage to artworks while in transit.

D) Artcite Inc. is not responsible for artworks left at exhibition site after exhibition run. Unless otherwise arranged in writing, works not removed within 3 days of exhibition closing will be removed at his/her expense.

E) Artist agrees not to inflict damage to or otherwise permanently alter the exhibition site. Walls/floors, etc. must be restored to original state following exhibition run.

F) The acceptable standards of the gallery and the artist(s) are agreed to at the onset of this agreement and they are as follows (i.e., policy, types of work exhibited, restrictions): the gallery reserves the right to restrict for exhibition any work that is in violation of public health, safety, or fire regulations, or otherwise contravenes the Canadian Criminal code; works that will permanently alter or otherwise damage “Visual Fringe” exhibition areas. The content of the work(s) to be exhibited under this agreement is known and understood by both parties.
